


Figure 1. Proposed Project Location and Vicinity

The Western Federal Lands Highway Division of the Federal Highway Administration (FHWA), in partnership with the City of Whittier, proposes to extend Shotgun Cove Road for approximately 2.5 miles from its existing terminus near Second Salmon Run (Mile 2.0) onto U.S. Forest Service (Forest Service) land at Trinity Point (Mile 4.5) in Whittier, Alaska. The Forest Service is a cooperating agency for this effort. Whittier is approximately 55 miles southeast of Anchorage, Alaska within the Valdez–Cordova Census Area. The project is located within Sections 3, 8, 9, and 17, Township 8 North, Range 5 East, Seward Meridian. The project can be located on the USGS Seward (D-5) SE Quadrangle (Figure 1). Because the proposed project is being funded by FHWA, the federal action is an undertaking subject to Section 106 of the National Historic Preservation Act.

The proposed project is located in a rural area currently used primarily for recreation with no roadway beyond the existing terminus. The proposed road extension would be constructed approximately 250 to 350 feet from the shoreline and would run roughly down the middle of City of Whittier-owned land, ending with a small parking lot at Trinity Point. Project design includes several spur roads to the north and south along the alignment to allow for future beach access points, trailheads for uplands access, and access to potential private parcels. The purpose of the proposal is to improve access to federal and state lands, alleviate pressure on Whittier's regional transportation system, and realize potential economic growth.

The majority of the roadway would be located on City of Whittier-owned land and would end with a parking area on Forest Service property. Construction of the main road section would include an approximately 80-foot wide clearing limit and would install two 10-foot gravel travel lanes, two 5-foot gravel shoulders, and rock catchment area. The smaller spur roads would consist of an approximately 65-foot wide clearing limit and two nine-foot gravel travel lanes. Construction would also include drainage swales or rock cuts along uphill sides and culverts at major creeks and small drainage features that meet Alaska Department of Fish and Game fish passage criteria where anadromous and resident fish species are present. Project activities would include geotechnical investigations; clearing and grading; placement of fill and gravel; culvert installation; signage and guardrail installation; and reestablishing vegetation in disturbed areas.

FHWA defines the area of potential effects (APE) for the proposed Shotgun Cove Road extension as a 200-foot corridor centered on the proposed 2.5-mile main and spur roads' center lines. In 2018, FHWA tasked Cultural Resource Consultants, LLC (CRC) with conducting a desktop study of the Alaska Heritage Resources Survey (AHRS) and an archeological field investigation of the proposed project area to identify cultural resources on or eligible for the National Register of Historic Places within the project area. The desktop study revealed that there are no known or documented prehistoric or historic archaeological sites in the project area. In August 2018, CRC led an archaeological field investigation of the proposed routes, and the fieldwork concluded that no cultural or historical resources were at risk from the proposed project. Nothing of prehistoric or historical archaeological significance was found during the survey and the area was determined to have little archaeological potential due to its steep topography and prevalent wetlands. The only cultural remains revealed by the field survey within the proposed project area were four culturally modified trees (CMTs) and many saw-cut stumps. According to the Alaska Office of History and Archaeology, individual or small groups of CMTs are not usually considered significant; though, their presence demonstrates past use of the project area (CRC 2018/2019; Appendix A).

Following completion of the 2018 cultural resources survey report, the proposed project was extended to terminate on Forest Service land. In September of 2019 CRC completed an additional archaeological survey for the Shotgun Cove Road extension revised proposed road terminus, which was included as an addendum to the 2018 survey. No additional historic or cultural resources were discovered as a result of the 2019 survey.

The APE was updated in May 2020 to include potential future development plats along the proposed alignment and now covers all of City of Whittier-owned land in the project area and Forest Service-owned land at Trinity Point (Figure 2). Based on CRC's study of the revised APE, they have recommended areas for additional fieldwork survey that were not covered in the previous two efforts and have the potential to contain cultural resources (CRC 2020; Appendix B). The additional study is planned for June 12-15, assuming approvals from the Forest Service are received.

We request your comments on the proposed project with regard to the potential for the project to impact historic properties, and the proposed methodology for additional survey of the APE. FHWA and the Forest Service will also consult with the Native Village of Eyak, Native Village of Chenega, Native Village of Tatitlek, Chugach Alaska Corporation, Eyak Corporation, Chenega Corporation, and the Tatitlek Corporation to determine if the tribes have interests or concerns regarding the project.






Figure 1. Project Location and Vicinity

The Western Federal Lands Highway Division of the Federal Highway Administration (FHWA), in partnership with the City of Whittier, proposes to extend Shotgun Cove Road for approximately 2.5 miles from its existing terminus near Second Salmon Run (Mile 2.0) onto U.S. Forest Service (Forest Service) land at Trinity Point (Mile 4.5) in Whittier, Alaska. The Forest Service is a cooperating agency for this effort. Whittier is approximately 55 miles southeast of Anchorage, Alaska within the Valdez–Cordova Census Area. The project is located within Sections 3, 8, 9, and 17, Township 8 North, Range 5 East, Seward Meridian. The project can be located on the USGS Seward (D-5) SE Quadrangle (Figure 1). Because the proposed project is being funded by FHWA, the federal action is an undertaking subject to Section 106 of the National Historic Preservation Act.

As a part of the design effort for this project, FHWA is proposing a geotechnical study. The purpose of this effort is to gather needed geotechnical information from locations along the proposed roadway alignment to support design of roadway stream crossings' culverts. This information is needed for the design to be developed to meet engineering and safety specifications.

Project Details

Three to five boreholes would be taken at the gravel staging area in previously disturbed areas at the end of the existing Shotgun Cove Road. Three boreholes (#1-#3) would be taken along the alignment near stream crossings along the alignment.

At borehole #1, the project team would clear a 50-foot radius around the boring site to provide a safe location for a helicopter to sling in equipment boring equipment and land to deliver geotech field scientists to the site. No clearing would occur below ordinary high water (OHW) of any waterbody, and all cleared material would be placed above OHW. The helicopter would place the small drill rig at the borehole location.

At boreholes #2 and #3, clearing would be limited and minor, since the landing locations would be within areas that are free of large trees and shrubs. The helicopter would sling in the drill rig and land to deliver field scientists to the site. The drill rig, equipped with tracks, would be moved no more than about 25 feet to the bore hole location.

At each location, the exploratory drill hole borings would be advanced using a small drilling rig. To obtain the borings at the existing gravel pad, a Geoprobe 3972 truck-mounted rig would be used. To obtain the borings along the alignment, a Geoprobe 1028 track-mounted rig would be brought in with a helicopter. Borings will be approximately 30-70 feet below ground surface. Borings through soil (likely only a few feet deep) would be 6 to 8 inches in diameter. Borings through rock would be 3 inches in diameter. Water would be pumped from adjacent creeks for the boring operation.

Water from the drilling operations would be directed to a small containment pool within uplands. In order to reach a suitable uplands discharge area, the discharge hose may be lain across and across creeks to reach the opposite bank. No water from drilling operations would be discharged into the creeks.

Area of Potential Effects




Figure 2. Proposed Area of Potential Effects




Figure 3. 2018/2019 Archaeological Surveys

FHWA defines the area of potential effects (APE) for the proposed geotechnical study as the 50-foot maximum clearing radius around each boring site. For the boring sites located in the previously-disturbed gravel pad, the APE includes the gravel pad only since no clearing is proposed (Figure 2). In 2018, FHWA tasked Cultural Resource Consultants, LLC (CRC) with conducting a desktop study of the Alaska Heritage Resources Survey (AHRS) and an archeological field investigation of the proposed project area to identify cultural resources on or eligible for the National Register of Historic Places within the project area. The desktop study revealed that there are no known or documented prehistoric or historic archaeological sites in the project area. In August 2018, CRC led an archaeological field investigation of the proposed extension that included a pedestrian survey of accessible areas of the proposed routes, and the fieldwork concluded that no cultural or historical resources were at risk from the proposed project. Nothing of prehistoric or historical archaeological significance was found during the survey and the area was determined to have little archaeological potential due to its steep topography and prevalent wetlands. The only cultural remains revealed by the field survey within the proposed project area were four culturally modified trees (CMTs) and many saw-cut stumps. According to the Alaska Office of History and Archaeology, individual or small groups of CMTs are not usually considered significant; though, their presence demonstrates past use of the project area (CRC 2018/2019; Appendix A; Figure 3).




Figure 1. Proposed Project Location and Vicinity






Figure 3. 2018/2019 Archaeological Surveys

2. Description of project status (FHWA, Solstice)

Robin Reich: Solstice started work with the city in 2018 and did early coordination with SHPO who wanted cultural resource survey and ADFG who wanted survey on salmon. In 2018 CRC did cultural resources work and salmon stream work. Engineers looked at 2 different alignments. Over 2018-2019 narrowed down to one alignment (low alignment). Also extended into forest service land. Did additional CR work in 2019. Meanwhile working on EA sections. Have consulted more with the SHPO, and expanded the area of potential effect (specifically doing more investigation into the shorelines).

We're trying to get NEPA environmental process wrapped up by end of 2020. Then work on environmental permits in 2021.

Josie: Do you anticipate any challenges or pushback from EA process, the public or permitting? Robin: Held a number of public meetings in Whittier. Public has asked about the indirect and cumulative effects of the project. Have talked with the USACE about wetland impacts. I'm not seeing any show-stoppers.

Scott Korbe: Funding started out with a land grant of over 600 acres from State of Alaska. Received WFL and State of Alaska money to work on the first segment. Expanded the project to go onto the FS. All in received \$5.5-6 million so far. Funding for the future is still up in the air. But we want to be ready to go if funding becomes available.

Yes, there will be land development out there at some point. Road fulfills several different purposes, access to native Corporation, access to FS land, access to future private land development. It's a team effort with all the groups working together.

Josie: I know Dave has been involved with this from the beginning. We're happy to do what we can to move this project forward. I would like to understand from a financial perspective. What is total cost?

Scott: \$25 million all in. Expensive to build per mile. There is a lot of bidding strategy. But we need to get EA and permits completed before we bid. Spent some money on Value Engineering to save money on the first road extension project.

Our engineer at CRW has done aerial and 3d renderings. What can we do with least visual impact. We'll get you the ability to look at that.

3. Sharing of information about cultural resource investigation conducted and preliminary findings (FHWA)

Josie: When do you expect a draft EA?

Robin: Looking at the end of the year.

Josie: Please give us a heads-up for our review.

Robin: We will provide the draft EA for review when it is completed. Cultural resources report will be available within the next month or so. We will provide then.

4. Inquiry to CAC if there is more information that can be provided (CAC) Josie: At the last phase we had an agreement and some of our gravel resources were used for the project. Is there any opportunity for Chugach to provide gravel/materials?

Seth: From a FHWA perspective, I would have to take that to management (to make sure we comply with all necessary regulations), but it has been noted.

Dave: Some of the gravel/rock resources seems to be competent. We would be willing to work with the project to provide resources. Also meets USACE requirements.

5. Inquiry to CAC if there is any information that they would like to share, including issues or concerns about the project or potential impacts to cultural resources (CAC)

Josie: Don't have any specific concerns. Will look for the updated report.

Dave: Our VP of cultural resources John Johnson is comfortable with Heather Hall and SHPO taking the lead.

Tim: Follow up for Dave. CR report and surveys were completed by Cultural Resources Consulting. FS has been involved in review.

Seth: FHWA also has an archaeologist in our office who is very familiar with the Section 106 process and working with SHPO, Tribes, and in Alaska.

Seth: Any specific issues or measures regarding the Geotechnical Borings? Dave: CAC is comfortable with the borings.

 - a. FHWA involvement is based on Federal Lands Access Program. Project twice received funds from the FLAP call for projects to access the FS land at Trinity Point. City of Whittier is delivering project, has hired a consultant team. FHWA-WFL is providing Stewardship and Oversight and is the federal lead agency for NEPA and all federal processes. FS is NEPA cooperating agency.
 - b. Consultant team hired for road extension in 2018. Looked at two options, high and low routes. Design constraints found that the low option was more feasible.
- 3. Sharing of information about cultural resource investigation conducted and preliminary findings (FHWA, Solstice)
 - a. In 2018 CRC and ADFG did surveys of both high and low options. Found a few culturally modified trees away from the alignments. Went back out in Summer 2019 to look at additional area especially at Trinity Point. Public meeting in January 2020. SHPO asked us to go out and look at more areas, mainly the beaches. We surveyed in June 2020 and didn't find any more cultural resources. We are updating the cultural resource report and hoping to be done in a month.
- 4. Inquiry to Chenega IRA and Chenega Corp. if there is more information that can be provided

- a. Larry Evanoff: If you do find artifacts, where is that going to go?
 - i. Robin: If they were found during survey work then they would have notified SHPO. If during construction, there are protections in place to stop construction and call SHPO to determine plan.
- b. Ben: Chugach Alaska Corp authorized party is John Johnson. We may want to consult with him
 - i. Robin: We have spoken with Chugach. My understanding is that John Johnson from Chugach has been involved.
 - ii. Robin: We will provide Cultural Report when it is completed
- c. Doug Fuller: Can you walk through what consultation was done with any of the native villages? Where I have seen this work well before, is that sort of process starts early on.
 - i. Seth: We have included Tribes in the project. We sent out government to government letters to the Tribes in the area. This is part of that consultation.
- 5. Inquiry to Chenega IRA and Chenega Corp. if there is any information that they would like to share, including issues or concerns about the project or potential impacts to cultural resources.
 - a. Larry E: Whittier is having a meeting tonight at 6pm regarding tsunami preparedness.
 - b. Ben: I'm interested in when is the earliest for construction? Is this funded or budgeted—do you have the money?
 - i. Samantha: Plan is to get the funds in 2021 or 2022, but we don't have a transportation bill so that affects funding. We are trying to push for 2021, but more realistically 2022.
 - ii. Ben: Is it federal funded?
 - 1. Sam: Yes, with a 9.03% local match. Currently the City is phasing the project. Designing the entire project, but will construct as they can.
 - iii. Ben: \$36.1 million and 2.5 mile project, is this expensive comparatively?
 - Scott: Project has a lot of wetlands and rock, so cost per mile is expensive. We will get a more refined cost estimate as the design is approved. Project all-in is likely more around \$26 million. Primarily developed for a few reasons: 1) limited recreational opportunities for residents and tourists and this opens up to more recreational opportunities. 2) potential for economic development.
 - iv. Ben: This feels like Phase 2 of the project. Is there a Phase 3—for an additional phase of work into Shotgun Cove?
 - 1. Robin: Engineers have looked at it, and it appears difficult to do engineering-wise.
 - 2. Scott: We applied for FLAP for permitting design and engineering for this 2.5 mile extension, and that is where the current money would run out. Looking to have project shovel-ready if funds are available. Another phase would be 5-10 years down the road.
 - v. Chuck: I understand trying to provide for your own community. But, my concerns are:

- 1. We've had some discussions with FS about their plan but the planning process hasn't really started. We have the Exxon Valdez habitat transaction agreement. My concern about development is we haven't completed our own planning cycle. This is traditional homeland for Chenega people. We use entire western Prince William Sound that it has failed to account planning under FS plan revision. I'm becoming more concerned with what I'd call development creep. Started with Whittier Access project, which was a well done project, and we use it. It also comes with development is more people which impacts resources. That planning cycle has not been started, much less completed. Have yet to consummate any agreement with the trustee council. We need to get our concerns on paper and haven't been able to do that. For us to say we have no problem with this is very premature. It can't be done in a vacuum, and that is what this feels like.
- 2. Tim: One of the concerns I hear is additional access and pressure on natural resources. I'd like to hear more on broader concerns with project
 - a. Chuck: We've been in this area for hundreds or thousands of years. There is an old village site in Little Bay. Historically used the W Prince William Sound. Maybe not in context of this project, but in a larger sense, want a study for the larger PWS. Thinks we're missing the bigger picture here.
 - i. Though could be a win-win situation.
- 3. Robin: Purpose of this road extension is to provide access to lands in and around Whittier. I've seen increase in usage in PWS, too.
- 6. Inquiry to Chenega IRA and Chenega Corp. if there are any alternatives or mitigation that would address issues.
 - a. Geotechnical Drilling
 - i. I don't see on this map drilling. **Seth to send out drilling map.** Scott: We plan surgical drilling with the rigs delivered via helicopters.
 - ii. Chuck: Is somebody making lots for private development?
 - iii. Scott: Alaska provided us land with idea that it would be developed. Our intent is to put land for sale and the road access would be seasonal and no utilities provided.
 - iv. Doug: Are those lots being proposed as residential/commercial?
 - 1. Scott: We're talking about family-style cabins with CCRs
 - 2. We're trying to make a nice road
 - 3. We'll send you a 3D terrain model
 - v. Chuck: Would Chenega corporation be allowed to buy the lots?
 - 1. Scott: Yes, we'd put them out and put them up for bid.
 - 2. Chuck: Would like to be part of that process. We would be interested in acquiring lots as they become available. We're taking more of a holistic approach. I see this as a good opportunity to house some of our people.

a. Scott: We're anywhere from 3-10 years away from being able to plat and sell those lands.




Figure 1. Proposed Project Location and Vicinity

The Western Federal Lands Highway Division of the Federal Highway Administration (FHWA), in partnership with the City of Whittier, proposes to extend Shotgun Cove Road for approximately 2.5 miles from its existing terminus near Second Salmon Run (Mile 2.0) onto U.S. Forest Service (Forest Service) land at Trinity Point (Mile 4.5) in Whittier, Alaska. The Forest Service is a cooperating agency for this effort. Whittier is approximately 55 miles southeast of Anchorage, Alaska within the Valdez–Cordova Census Area. The project is located within Sections 3, 8, 9, and 17, Township 8 North, Range 5 East, Seward Meridian. The project can be located on the USGS Seward (D-5) SE Quadrangle (Figure 1). 


Figure 2. Proposed Area of Potential Effects





Because the proposed project is being funded by FHWA, the federal action is an undertaking subject to Section 106 of the National Historic Preservation Act.

The proposed project is located in a rural area currently used primarily for recreation with no roadway beyond the existing terminus. The proposed road extension would be constructed approximately 250 to 350 feet from the shoreline and would run roughly down the middle of City of Whittier-owned land, ending on Trinity Point. Project design includes several spur roads to the north and south along the alignment to allow for future beach access points, trailheads for uplands access, and access to potential private parcels. The purpose of the proposal is to improve access to federal and state lands, alleviate pressure on Whittier's regional transportation system, and realize potential economic growth.

In 2018, FHWA tasked Cultural Resource Consultants, LLC (CRC) with conducting a desktop study of the Alaska Heritage Resources Survey (AHRS) and an archeological field investigation of the proposed project area to identify cultural resources on or eligible for the National Register of Historic Places within the APE. The desktop study revealed that there are no known or documented prehistoric or historic archaeological sites in the APE. In August 2018, CRC led an archaeological field investigation of the proposed extension that included a pedestrian survey of accessible areas of the proposed routes, and the fieldwork concluded that no cultural or historical resources were at risk from the proposed project. Nothing of prehistoric or historical archaeological significance was found in the APE and the area was determined to have little archaeological potential due to its steep topography. The only cultural remains revealed by the field survey within the proposed project area were four culturally modified trees (CMTs) and many saw-cut stumps. According to the Alaska Office of History and Archaeology, individual or small groups of CMTs are not usually considered significant; though, their presence demonstrates past use of the project area.

Following completion of the 2018 cultural resources survey report, the APE was extended to terminate on Forest Service land. In September 2019, CRC completed an additional archaeological survey for the Shotgun Cove Road extension revised proposed road terminus. The APE was then expanded to the limits of City of Whittier-owned land. Additional fieldwork survey was recommended for areas that were not covered in the previous two surveys. A pedestrian survey of the entirety of Trinity Point, as well as accessible coastal portions of the APE was completed in June 2020. No additional historic or cultural resources were discovered as a result of the 2019 or 2020 surveys, and CRC concluded that the proposed project will have no effect on historic properties (CRC 2020; Appendix A).

FHWA agrees with CRC's findings and recommends a finding of No Historic Properties Affected Section 106 determination for the Shotgun Cove Road Extension Project, AK Whittier 2016(1). FHWA sent a letter on October 5, 2020 requesting the Alaska State Historic Preservation Officer's concurrence with this recommendation. Please review the attached cultural resources survey report and contact FHWA prior to November 5, 2020 if you have comments.

The Forest Service, as a cooperating agency for this project, has reviewed and agrees with the FHWA recommendation. As per the 2017 Programmatic Agreement Among The USDA Forest Service, Alaska Region, The Advisory Council on Historic Preservation, and The Alaska State Historic Preservation Officer Regarding Heritage Program Management on National Forests in the State of Alaska, the Forest Service will not be initiating a separate consultation with the Alaska State Historic Preservation Officer for impacts to Trinity Point.
